- Document non-functional requirements which can be traced back to solution and business requirements, so that these can be used when liaising with key stakeholders to obtain approval for the solution design.
- Analyse and design the infrastructure components of projects to meet the project deadlines, technology requirements and VWG UK standards.
- Govern the design and implementation work of any 3rd parties and suppliers who will deliver any work in collaboration with the Architecture and Security Team in VWG UK IT
- Ensure that infrastructure needs of any COTS, factory system adoption or bespoke developments proposed as a part of any project are evaluated appropriately and the necessary approvals are obtained.
