Job Purpose

The IT Portfolio Delivery Manager is responsible for the specific Projects assigned to the VWG UK IT Portfolio. Projects will support the delivery of Infrastructure and Technical Projects within VWG UK IT working with the IT Operations function. They will work across the Operations and Infrastructure teams to identify critical IT Projects that must be delivered to manage core Security and Lifecycle topics.

The Portfolio Manager's Portfolio will range in value from £3-£4 million.

Responsible for both assignment and line management of the Project Manager's ensuring they manage all business and technical activity (with internal and external partners) to deliver Projects in line with quality and scope objectives as well as on time and within budget.

To support the Head of Portfolio Delivery and Software Development in providing accurate financial and status information and supporting key stakeholder management activities.

Key Areas of Responsibility

- Responsible for the delivery of the portfolio demand to time, budget and quality.
- Supporting PMs in delivery, risk assessment, costing and executing detailed plans using defined tools, methods, processes & procedures.
- Line management of the Project Managers as well as allocating and supporting them in the Delivery of the Portfolio.
- Working with IT Operations and Infrastructure teams to agree the roadmap for delivery, specific to IT Projects and Lifecycle Management.
- Supporting the Head of Portfolio Delivery and Software Development with Portfolio Planning, Forecasting and Communication.
- Determining the methodologies and approaches to deliver Projects in line with VW standards and ensuring their adoption (IT PEP, Waterfall, Agile).
- Defining, securing, monitoring and controlling the resources required to manage and execute Project activity.
- Plan, define and scope assigned Projects to company standards using defined tools, methodologies, processes and procedures, to create well defined projects which align with Business and IT strategies.

- Ensure that Project, quality, change control and risk management processes are implemented on all assigned projects, so that any issues and risks can be identified and responded to.
- Acquire the resources and skills needed to create a Project team that can deliver the project objectives, managing performance as required to ensure projects are delivered within agreed parameters of cost, timescales and quality.
- Monitor and control resources (including third parties) and costs against the project budget.
- Responsible for the assessment, selection, performance and ongoing management of third-party providers engaged in delivery.
- Responsible for providing transparent documentation of the Project to agreed VW standards, so that there are auditable records as per the IT PEP methodology.
- Ensure Projects are effectively, documented, implemented and handed over to those parties charged with ongoing support, maintenance and development.
- Provides effective leadership to the project team and takes appropriate action to ensure the team performance doesn't deviate from agreed tolerances.
- Ensures that projects are formally closed and, where appropriate, subsequently reviewed and that lessons learned are recorded and implemented.
- Manage assigned Projects from initiation to close (and review where appropriate), in line with defined company standards, to ensure that projects are delivered to agreed cost, time and quality measures, and meet their overall objectives.

- Must be diplomatic and persuasive.
